INFRASTRUCTURE

The latest communication systems, including VOIP phones, video, and audio conference devices are installed for smooth interaction with our foreign clients.

Training rooms are equipped with multimedia projection systems, net conference facilities, and workstations connected to the network for online training.



SECURITY MEASURES
